These changes, along with all sorts of information, are shared with your Local Swimming Committee (LSC) Officials Chairs during their quarterly calls. This past summer, we altered the format for the LSC OC quarterly calls to have a greater focus on the requests of the LSC OCs, and we also include a brief educational component at these meetings. If you have a lingering question, ask your LSC OC. If they do not have the answer, they can bring it to the quarterly meeting for an answer. It is expected that all LSC OCs will share the information from these quarterly calls with their LSC officials. This added information can only enhance our performance and "job satisfaction" as volunteer officials. Another venue where information is shared regularly is in the National Officials Committee quarterly call. The NOC meeting is an opportunity for NOC members to share the work that they have completed and what they are working on. Both of these meetings are posted under "Events" on the USA Swimming website and are open for you to observe if you would like. Tips for Training

On-deck training of apprentices is a critical responsibility we all share. Any official certified for at least a year can be called upon to serve as an on deck trainer for apprentices.

Here are a few quick tips for a productive training session:

- Introduce yourself. Make the apprentice feel welcome.
- Review the position responsibilities and the rules that the apprentice will observe during the session.
- Position yourself so the apprentice can clearly see and you can easily converse while you
 officiate.
- Engage the apprentice in an inquisitive way. What did you see? How would we describe that? Help the apprentice learn to describe observations according to the rules.
- Let the apprentice fill out any DQ slips, which you check and sign, and explain the call to the Referee or CJ.
- Spend a few minutes with the apprentice at the end of the session to fill out the paperwork and answer any questions.
- Thank the apprentice for working to become a certified official. (And thank you for being part of that process!)

There are minimum requirements for Open Water certification and OW Clinics are an integral part of that process.

Clinics are usually initiated by an LSC or Zone representative and can be done online or in person, depending on time, location, and clinician availability. Clinicians should be contacted directly to check their availability and interest.

While the clinic host will promote the event in their local area, clinicians will also send information to the NOC LSC Liaison, who will share the information with all Officials Chairs. The information may also be posted on the USA Swimming Officials Facebook page. The intent is to make these Clinics available to officials across the country.

Our Kids Initiative (OKI)

Our Kids Initiative is a cooperative effort of the leadership from the member organizations of the 11 governing bodies and associations to "Putting ALL of Our Kids First." Its purpose is to find ways for competition to be as fair as possible, regardless of the organization the swimmer is representing. Additionally, members are working together to find ways to help each other in making swimming in the U.S. the best activity for all Americans.

The initial work to get what ultimately became OKI was initiated by Pat Lunsford of Ohio in 1990. Now in its 25th year, the program was officially formed in 2000 to bring leaders together from all swimming organizations to discuss what could be done to help swimmers in the United States have the ability to compete without fear of being disqualified, regardless of whether the competition was held under World Aquatics-AQUA (formerly FINA), NCAA, NFHS, USA Swimming, U.S. Masters Swimming or YMCA rules.

After the Paris Olympic Games in August, the committee members of ASCA, CSCAA, CSOA, AQUA, NCAA, NFHS, USA Swimming, USMS, and the YMCA met virtually via Zoom to continue collaborating regarding recent rules changes by World Aquatics, and discussed the possibility of changes that would be implemented after the 2025 World Championships in Singapore. The different rule-making bodies have different processes and timeframes for adopting and implementing new rules. The reasons for the different implementation schedules are the timing of Championship-level meets and coaches, athletes and official education. As a Member of World Aquatics, USA Swimming is obligated to adopt technical rules changes. As always, the USA Swimming Rules and Regulations Committee and the National Officials Committee will communicate any changes and details regarding implementation should any changes be forthcoming. Again – if there are changes, the likely implementation would be approximately a year away.

The meeting was also an opportunity to discuss safety and training initiatives by each group and how those resources can be shared. The meeting was a resounding success, reinforcing our unwavering commitment to work together for the betterment of the sport for all of our athletes. Our next meeting will be in August 2025, unless the group feels that an interim meeting sooner.

Many officials work across multiple organizations. One challenge officials have when working across different rule-making bodies is maintaining a keen understanding of the differences in rules among the sanctioning organizations. OKI maintains a "Rules Differences" and "Water Depth Differences" summary chart to assist officials with that challenge. These documents are on the OKI website HERE. Pinnacle Awards - 2023 & 2024

The Pinnacle Award, formerly the Kenneth J. Pettigrew Award, is the highest honor given annually to an official whose robust volunteer service spans decades. Recipients of this award have made significant contributions at both the LSC and national levels, and exhibit attributes of servant-leadership through work in governance and the highest officiating positions. Selected by the National Officials Committee, the Pinnacle Award is presented each year at the USA Swimming Annual Business Meeting.

Marianne Walling of Indiana Swimming won the 2023 Pinnacle Award for her dedication to developing mechanisms for tracking officials participation, to be matriculated back into the new OTS once built, into SWIMS. Her efforts have spanned over two years and she has gracefully led her working groups to manage this massive project while working collaboratively as the Subject Matter Expert for the USA Swimming staff.

Jamie Cahn of Maryland Swimming won the 2024 Pinnacle Award for his leadership as the Meet Referee for the 2024 Olympic Trials. Jamie led a group of 70 officials through months of pre-meet preparation integrating with USA Swimming staff, local LSC leaders, television, and other key partners to deliver a technically flawless and fair meet for our highest performing athletes.
