ST, AO, & SR Online Clinics/Tests

We are more than a month into having the Starter and AO training in the USA Swimming University library. I hope you are seeing success with these clinic offerings.

USA Swimming has been receiving "help" requests regarding officials' tests not appearing in the officials' OTS record, which is causing delay in certification in some instances. This tells me that we have not clearly communicated to you, and for that I apologize.

Please take a moment to review the LSC Officiating Standards [HERE](#).

The new online ST, Starter and AO clinics provided by USA Swimming in the University Library are the required clinic and test all rolled up into one (pretty handy dandy). So, if an official has successfully completed the online clinic, then they have met the requirements of attending a clinic *and* completing the test. REMINDER: Scroll all the way down after completing the online clinic and complete the survey. If you do not complete this step then your work will not be recorded!

The Referee online training is underway and is on target for release in the spring. Until that release, please continue to use your LSC Referee training clinic and the online Referee test to fulfill these components of the LSC Officiating Standards for Referee certification.

Training Course Fees

Beginning in January 2025, non-members will be charged for the Officials' Certifications courses in the USA Swimming University. These courses, as well as most of the courses in the USA Swimming University, will remain free for members. Non-member pricing will help support and maintain the courses and platform. In order to continue taking advantage of the \$0 pricing, all prospective officials, officials in training, and new officials must register as a member or apprentice prior to taking the online training.

OTS

Since we opened the national certification application on October 24, many excited officials have tried out the streamlined process. We are thrilled to see new officials' names appearing; however, please ensure you have attended an Officials Qualifying Meet (OQM), received an evaluation, and the sessions you've worked at the OQM are entered into the meet before clicking the submit button. If you are unsure what an OQM is, please contact your LSC Officials Chair for guidance. If you are still looking for the application, you can find it under the Officials tab in the blue banner.

Everyone who is nationally certified should now see their national certifications reflected in OTS. We are still working through some processes, so if something seems off, check back after a week and then reach out. If you notice that an expiration date and an effective date are the same in the system, that indicates an invalid certification, which will eventually be removed. Review turnaround time is back to two weeks during normal months, but it may take longer during peak application months, specifically March, April, July, August, and December. Did you know that from March 2023 to October 24, 2024, while OTS was being redeveloped, over 2,500 applications were processed?

New reporting features have been introduced for Officials' Chairs to assist with mentor identification and to support those advancing within the LSC. Meet Referees and LSC Officials Chairs now have access to a session report from within a meet, which includes names, IDs, emails, and sessions worked.

The 2024 Official Qualifying Meets (OQM) count is on target with nearly 200. Fifty-one LSCs submitted applications. These meets offer excellent opportunities for formal mentoring, both within and outside the LSC. If you have never attended one, give it a try, as there is always something to learn and new officials to meet.

Underwater cameras have been the talk of the town, but there is another advancement that is crucial in officiating relays: the RJP - Relay Judging Platform.

Looking for more details on the Officials' Excellence Award?

The Officials Excellence Award:

- National recognition for outstanding officials for LSC contribution
- Anyone can submit, although we will ask OC or GC for input
- The nominee must be an active member with current registration
- Six are awarded in a year, one each in odd-numbered months
- Nominations close around April
- Nominations are held for two cycles (24 months) unless selected
- NOC votes in May for the July through next May period (1 cycle)

Hopefully, your LSC OC committee is actively looking for ways to acknowledge officials and appreciate
