Applications typically close four months (~120 days) prior to the meet start date, but applications may close earlier if a sufficient number of applications have been received.

Officials' Excellence Award

Congratulations to the August winner of the Officials' Excellence Award: Ellen Colket from Potomac Valley Swimming.

Ellen Colket has been an official for more than 20 years. Ellen spends most weekends on a pool deck, either as an official just helping at a local meet, or as a meet referee, mentor, or evaluator. Although she is very active on the national officiating scene, she is also a frequent volunteer at all levels of meets in Potomac Valley Swimming (PVS). The Officials' Excellence Award:

- National recognition for outstanding officials for LSC contribution
- Anyone can submit, although we will ask the LSC Officials' Chair or LSC General Chair for input
- The nominee must be an active member of USA Swimming with current registration
- There are six awards each year, one each in odd-numbered months
- Nominations close around April
- Nominations are held for two cycles (24 months) unless selected
- The National Officials Committee votes in May for the July through next May period (1 cycle)

Hopefully, your LSC OC committee is actively looking for ways to acknowledge officials and appreciate their service at the local level. This award is just a way to further acknowledge those deserving higher recognition. The link for the nomination form is [here](#).
