



## Giving Thanks for USA Swimming Safe Sport

We've had an exciting year promoting athlete safety through many initiatives. Congratulations and thank you to every club that became [Safe Sport Recognized](#) (SSRP), members who participated in free training, and USA Swimming Safe Sport Chairs/Coordinators who worked all year to prioritize athlete safety in their communities.

Here are some 2024 highlights the USA Swimming Safe Sport staff are thankful for in November:

- From January-October, **11,434 individuals took advantage of non-required free education**, with 5,542 participating in online parent and athlete education.
- **87 clubs became SSRP approved** for the first time. **210 clubs renewed** SSRP approval.
- **746 clubs participated in free individualized training** opportunities from USA Swimming Safe Sport staff, LSC Safe Sport Chairs, and/or Club Safe Sport Coordinators.
- **Inland Empire LSC** has the highest percentage of clubs SSRP approved with almost **69%**!
- **North Carolina LSC** and **New England LSC** are tied for the highest total with **33 clubs SSRP approved**.
- This year, **all LSC Safe Sport Chairs** and **Club Safe Sport Coordinators were offered free, live training** to support their roles at the local level. For those unable to attend, a recording was sent via email.


