

Technical Release Notes: August 12, 2025

We're excited to announce the August 2025 release, which includes key improvements to LSC management, National Team workflows, meet processing, and reporting. Highlights include the successful rollout of the New Ohio LSC merger, updates to the National Team Groups features, enhanced handling of meet time uploads, and new reporting tools for compliance and Club Excellence.

Developer Spotlight: Nick Okeefe

Nick Okeefe has played a pivotal role in building the new National Team Group Registration system, which supports Team USA athlete onboarding and data management. His work spans multiple releases, from the initial launch to recent enhancements in invite logic, and ACH upload handling. Nick's focus on data accuracy has significantly strengthened the NT registration process. Thank you for your outstanding contribution!

Ohio/Lake Erie LSC Merger. Created a new Ohio LSC by merging the former Ohio (OH) and Lake Erie (LE) LSCs. All clubs were reassigned, and legacy LSCs were retained for reference in historical data and searches.

- Created new Ohio LSC, reassigned all clubs from OH and LE, and marked old LSCs as expired.
- Validated that legacy OH and LE LSCs still appear in Member and Club search results for historical continuity.

LSC Merger Workflow Fixes and Enhancements. Follow-up updates to ensure workflows, UI components, and legacy LSC data display correctly after the merger.

- Fixed club search filter to accurately respect the LSC selection for current vs. not current status.
- Removed expired LSCs from HQ OTS Bulk Recertification dropdown options.
- Updated Club Manage Offerings to properly show historical offerings post-merger.
- Updated OTS Meet Official selection screen to reflect accurate LSC-club affiliations and expiration data.
- Updated OTS Meet Officials display to reflect accurate affiliations and dates.
- Ensured Purchase by Check functionality now displays accurate LSC-club combinations.
- Updated My Athlete Meet Entries to display accurate LSC-club associations for historical meets.

National Team - Group Registration Enhancements. Several enhancements were made to streamline National Team group registration, improve data handling, and align workflows with current operational needs.

- Updated Group History Reports to reflect recent UI and data changes.
- Refined athlete invite logic to improve group handling.
- Updated the ACH upload area and NT apparel management process.
- Modified the athlete add process to utilize the LSC dropdown for consistency.

Competition – Meets. Improve Times Upload Process with Asynchronous Processing to further strengthen the asynchronous meet upload process, timeout handling was improved to ensure large file uploads complete successfully.

• Added measures to handle Meet Times Upload recognition timeouts.

Reporting Enhancements - New and updated reports to support group compliance tracking, Club Excellence evaluations, and third-party vendor data collection.

- Added a new Groups Compliance Report to monitor key requirements and participation.
- Enhanced 3rd Party Vendor API reporting to include U.S. citizenship status for compliance and analytics.

Bug Fixes - This release includes key bug fixes that improve data accuracy, report reliability, and membership logic. The following issues were resolved:

- Lenex LEF File Upload Bug: Corrected parsing logic to accurately handle decimal zeros in LEF relay splits. Relay splits were incorrectly loaded when a zero appeared to the right of the decimal. e.g., 27.05 being misread.
- Third Party Registration Enhancements. Fixed an issue preventing athletes originally registered through a third-party integration and later canceled from being re-registered. Updated logic to allow re-registration of canceled third-party athlete records.
- My Family Merge Member Bug. Resolved an issue where deleted users appeared in the family member selection list during club registration, causing confusion and potential data integrity concerns. Removed deleted members from display in family grids and merge options.
