  - d. Only allow one head coach per club – add head coach for a risk management purposes, but the true HC must be in compliance

    - i. Register New Member changing to Register Member
    - ii. Will show pending transfers
    - iii. Bold club name/code to make it clearer of which club you are renewing with
  - b. New processes through club’s registration link
    - i. Can upgrade athlete’s membership
  - c. All family members will show whether they just expired or expired a while ago
    - i. Will be able to hide family member so that they are not totally removed from account
    - ii. Will be able to hide an expired membership type card
  - d. What about Confused? Click Here
    - i. Maybe change the button color
    - ii. Change Confused to something else
