## OVERVIEW

---

### PURPOSE

The Safe Sport Club Recognition Program allows a USA Swimming member club to demonstrate their commitment to creating an abuse-free, safe, healthy and positive environment for all of its members through the development and implementation of Minor Athlete Abuse Prevention and Anti-Bullying policies, Safe Sport Best Practices and Athlete Protection Training.

### WHAT'S INVOLVED

- Policies, procedures and best practices: clubs will develop and/or share their Athlete Protection Policies and the other measures to safeguard athletes.
- Personnel: a big part of successfully implementing Safe Sport is getting the right people involved. Clubs will demonstrate the screening and selection procedures for staff and volunteers.
- Training and education: clubs will be awarded points when minor athletes and parents complete the Safe Sport online courses, as well as hosting in-person Safe Sport-related training.
- Reporting: clubs will detail communication to members about how to report misconduct to USA Swimming Safe Sport and the U.S. Center for SafeSport.

### WHERE TO APPLY

USA Swimming member clubs apply for Safe Sport Club Recognition through SWIMS. The Safe Sport Club Recognition Program application is located on the "Club" tab. The application can be accessed by the roles of [Club Administrator and Safe Sport Coordinator](#).

### WHAT IS REQUIRED BEFORE THE APPLICATION CAN BE SUBMITTED?

Safe Sport Club Recognition applications are scored for the Safe Sport Club Recognition in the following four areas:

1. Business/Organization Success;
2. Swim Parent/Volunteer Development;
3. Coach Development/Education; and
4. Athlete Development/Performance

In each of the four scored sections there are required components and additional components. *The required components of each section must be met in order for a team to be eligible to submit its application.* Additional components must be added to equal a total score of 75% completion, or 51.00 points. Safe Sport Club Recognition can be renewed every 2 years.

<p><b>Conduct Pre-Employment Screening</b> As a condition of membership, USA Swimming member clubs are required to conduct pre-employment screens on their new employees. This applies to those who are required to be USA Swimming members by USA Swimming rules. &lt;click the yes box if your club does the required pre-employment screening&gt;</p>		2 points
<p><b>USA Swimming Code of Conduct Communicated to Club</b> Club has documented it distributed the USA Swimming Code of Conduct to all members and they have received it. &lt;Click the yes box if your club has communicated the USA Swimming Code of Conduct to membership&gt;</p>		2 points
<p><b>MAAPP</b> USA Swimming requires member clubs to implement the Minor Athlete Abuse Prevention Policy (MAAPP) effective as of October 16, 2024. USA Swimming member clubs and Local Swimming Committees (LSCs) are required to implement the Minor Athlete Abuse Prevention Policy in full. This policy addresses risk areas that present opportunities for abuse to occur. The policy covers five (5) areas:            1. One-on-One interactions;            2. Travel: Local and Team;            3. Social Media and Electronic Communication;            4. Locker Rooms &amp; Changing Areas; and            5. Massages &amp; Rubdowns. <p><b>Photography Policy</b> A photography policy is another way to enhance the protection of athlete members. A photography policy could include no picture taking from behind the blocks and could require anyone taking pictures to do so from a certain blocked-off location of the pool deck. The policy must include how parents can opt in or out of having their child photographed at team functions, including swim meets. **SWIM PARENT/VOLUNTEER DEVELOPMENT**

**Total Category Points Available: 18**

**Minimum Points Needed: 8 points minimum, with at least 8 points from REQUIRED.**

<p><b>Safe Sport Club Coordinator</b> Does your club have a designated Safe Sport Club Coordinator who is a non-athlete member of USA Swimming? This ensures that the individual is background checked and has taken the Athlete Protection Training. <p><b>Online Safe Sport Education for Parents (1-5)</b> Safe Sport's online course for parents provides an introduction to Safe Sport, abuse and reporting information. There are three ways in which parents can earn credit for education: 1. Through the online catalog; 2. By attending a group training or attending provided by the team; or 3. Attending a USA Swimming Zoom live training. <p><b>Board/Staff Membership</b> It is required that all adult employees and the board of directors of a club are non-athlete members of USA Swimming. This ensures individuals are background checked and have completed the Athlete Protection Training. Please include a board/staff roster or a link to where this roster is posted on your team website. Some examples of individuals:  <ul style="list-style-type: none"> <li>• Adult employees of USA Swimming, Local Swimming Committees (LSCs) and member clubs;</li> <li>• Adults serving on the board of directors of USA Swimming, LSCs and member clubs;</li> <li>• Individuals in a position of oversight over the operations of a member club;</li> <li>• Adults with an ownership interest in a member club;</li> <li>• Referees, starters, administrative officials, chief judges, stroke and turn judges; and</li> <li>• Other volunteers who interact directly and frequently with or have authority over athletes (as defined in the SafeSport Code for the Olympic and Paralympic Movement) as a regular part of their duties.</li> </ul> <b>For institutionally-owned clubs (e.g., clubs owned by a YMCA, LifeTime Fitness, college/university, JCC, etc.), this applies only to:</b>  <ul style="list-style-type: none"> <li>• The adult employees with direct oversight responsibilities over the club's activities;</li> <li>• The adult employees who have direct club-related responsibilities and whose responsibilities are not to all others using the facility (e.g., this would not apply to a lifeguard assigned to the aquatics facility whose duties are related to all in the aquatics facility as opposed to only the member club athletes); or</li> <li>• The adult board members with direct governance/oversight responsibilities over the club's activities.</li> </ul>           &lt;Please make sure your staff are listed somewhere on your team website or email a staff roster to <a href="mailto:ssrp@usaswimming.org">ssrp@usaswimming.org</a>&gt;</p>		2 points
