Additional upgrades were delivered across membership management, LMS integration, and reporting to improve accuracy, automation, and user experience.

His thoughtful design and tireless work brought to life a smarter registration flow, staff role management, and compliance acknowledgments. Robb completed over 36 individual tasks and logged more than 250 hours to modernize the end-to-end onboarding process—demonstrating exceptional ownership and attention to detail.

New Club Application Phase II

Fee Management & Offerings – Implemented differentiation between a club and an organization for NCA notification workflow. Updated logic to distinguish club vs. organization for NCA-specific notifications.

Club Facility Affiliations - Added Help Text for Club Visibility Settings and enhance Find-a-Team support. Added help text for club visibility settings. Implemented facility affiliation type selection. Updated Find a Team data pipeline to support new "Show Find a Team" flag. Updated UI to support "Include in Find a Team" checkbox changes.

Application Submission & Workflow - Add admin and HQ tools to modify registration settings and fee logic. Implemented admin ability to change registration type. Added HQ override for standard club fee structure.

Facility Contract & Emergency Plans - Improve facility management interface and streamline document uploads. Updated Learn to Swim and NCAA facility screens. Added emergency/safety plan header.
Enabled uploads for facility plan documentation. Removed outdated facility contract step.
Organization club can now submit a New Club Application through a separate workflow. - Support new org-level workflows for club onboarding. Fixed download button for application workflow.
Implemented new "Organization Add" flow for incoming club records.

Develop a "Grid" Common Component to Use Globally - A new reusable grid component has been developed to support consistent layout and behavior across the SWIMS platform. This update introduces expandable row logic and prepares the system for future UI modernization.

National Team Groups V1 Post Add-On Features - This release includes several UI enhancements to support post-launch improvements in the National Team Groups module. Updates include new toggles, expanded sizing input, and refinements to registration views.

Competition Records - Records Automation Updates. This update automates and expands the handling of American records. New records now flow automatically into reports, are included in the public record list, and undergo eligibility validation for U.S. sport citizenship.

Block Party Summer Spectacular Updates - Series Updates. We've introduced branding and rules updates for the Summer Spectacular series to enhance the Block Party experience and improve clarity on leaderboard criteria. Added new Summer Spectacular logo to the Block Party leaderboard. Updated the Block Party leaderboard dashboard to reflect Summer Spectacular rules.

Membership Member Details - Ensure Accurate Enforcement of 60-Day Transfer Rules - We've improved the logic for athlete transfers to ensure the 60-day rule is accurately enforced. Removed the 60-day restriction when transferring an athlete to "Unattached" (UN) status.

LMS – Fix LMS Course Canvas Update Handling - Improved the logic for handling LMS course updates from Canvas to ensure accurate synchronization of course completion data. Evaluated root cause of Canvas sync failure and determined level of effort for resolution.

Reporting Enhancements - This release includes expanded reporting functionality to improve visibility across LSCs, clubs, and meet-related activity.

OME Team Contact Report

Created a new report to separate LSC and Club Names in the OME Team Contacts Report.

LSC Records Report

Added filtering parameters to the LSC Records Report for more refined reporting options.

LSC Years of Service Report

Developed a new LSC Years of Service Report to support staff recognition efforts.

Meet Times Uploaded Report

Updated the Meet Times Uploaded Report to reflect improved data accuracy and clarity.

Club Records Report

Made UI and data updates to the Club Records Report to align with new recordkeeping requirements.

LSC VCC Details Report

Launched a new LSC VCC Details Report for enhanced tracking of LSC-level compliance and oversight.

Bug Fixes - This release includes key bug fixes that improve data accuracy, report reliability, and membership logic. The following issues were resolved:

- Fixed an issue causing duplicate Safe Sport DB enrollments.
- Resolved an issue where "One Button" Outreach renewals were incorrectly registering athletes as Premium members.
- Corrected a defect in the My Family Merge workflow causing member data discrepancies.
- Fixed a bug where observed meets were missing from the Meet Times Uploaded Report.
- Updated Membership Requirement Reports to show only non-expired members as intended.
